# French Cour de cassation: Arbitrators' duty to disclose / parties' duty to investigate

On 16 December 2015, the French Supreme Court ("Cour de cassation") confirmed that an arbitrator had breached his duty of disclosure by not revealing an operation that was manifestly of importance to his law firm. This firm had been advising Leucadia corporation ("Leucadia"), the parent company of Caribbean Fiber Holding ("CFH"), which was codefendant with [...]


