Created in 2017, Case Law Analytics has developed a legal risk assessment solution based on the analysis of legal texts and the use of artificial intelligence and probabilistic models. The solution makes it possible to simulate the possible outcomes of litigation proceedings in more than twenty legal areas covering civil law, business law, social law. It provides assistance in defining the best strategy to adopt to resolve a dispute, and easily find the case law closest to the case in question to better defend it.

This acquisition is an attractive opportunity for LexisNexis to bring together Case Law Analytics with LexisNexis AI and generative AI legal solutions.
